What is this product?

Type

This is an open-ended investment company with variable capital segregated liability between sub-funds, incorporated with limited liability in Ireland.

Objectives

Investment objective The Fund seeks to achieve income and growth primarily through investment in debt securities of governments, government agencies, supranationals and corporates, who are based in the emerging markets of Latin America, Asia and Europe. The Fund may also invest in money-market securities and mortgage-backed and asset-backed securities.

Investment policies The investment manager will actively select, purchase and sell securities with the aim of meeting the investment objectives of the Fund.

The Fund will invest primarily in debt securities issued by corporations.

The Fund may also invest in government securities, quasi-government entities and money-market securities.

The Fund may use derivatives with the aim of managing interest rate and currency risk more efficiently.

The Fund may also use derivatives for both hedging purposes and for taking investment positions. These may include short positions where the Fund seeks to benefit from the sale of an asset that it does not physically own.

SFDR Classification The Fund has been classified as a financial product subject to Article 8 of the Sustainable Finance Disclosure Regulation (EU) 2019/2088.

Benchmark The Fund is actively managed with reference to a Benchmark. The performance will be used against 70% J. P. Morgan EMBI Global Diversified Bond Index / 30% J. P. Morgan GBI-EM Global Diversified (USD unhedged). The Index is used (i) as a universe from which to select or hold securities; and (ii) to measure performance of the Fund.

The investment manager has discretion over the composition of the portfolio of the Fund and may select securities not included in the Index. However, in normal market circumstances, whilst it is expected that a significant portion of the Fund's constituents will also be Index constituents, deviations from the Index may be material. Whilst the investment manager does not employ a defined strategy to align with a benchmark during periods of volatility, it will take account of market environment and perceived risks at any given time and

will employ its investment discretion as described in the investment policy accordingly.

Redemption and Dealing Shares can normally be bought and sold on any business day, being a day on which banks are open for business in Ireland, the UK and the US.

Distribution Policy Your shares are accumulating, meaning that income and gains of the Fund will be reinvested to increase the value of the Fund.

Launch date The Fund was launched on 15/07/2002 and the share class was launched on 15/07/2002.

Fund Currency The base currency of the Fund is USD and this share class currency is USD.

Switching Shareholders may switch some or all of their Shares in one Fund to Shares in another Fund.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 3 years and are prepared to take on a medium-low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the Directors of the Company as set forth in the prospectus, the Fund cannot be automatically terminated. The Investment Manager is not entitled to terminate the product unilaterally.

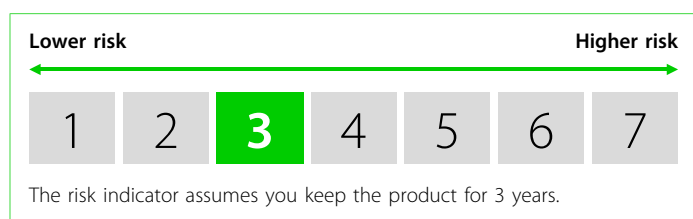

What are the risks and what could I get in return?

Risks

Performance scenarios

What happens if the Fund is unable to pay out?

You may face a financial loss if the Fund defaults on their obligations. If the Fund is unable to pay you out what the Fund owes you, you are not covered by any guarantee or national compensation scheme. The assets of the product are held in safekeeping by the Depositary and are separate assets to those of the Fund. Therefore, in the event of the insolvency of the Fund, the products and assets will not be affected. In the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence or intentional failure properly to fulfil its obligations (subject to certain limitations). In the worst case, however, you could lose your entire investment.
