# WHAT IS THIS PRODUCT?

#### Type

Pictet Alternative Funds - Myriad is a Compartment of an open-ended investment company with variable capital (SICAV) with segregated liability between Compartments and is authorised as an alternative investment fund in Luxembourg.

# Term

This product has no maturity date.

The Compartment is formed for an indefinite period. However, the Board of Directors may in certain cases decide to close the Compartment or at any time propose to close the Compartment at an extraordinary general Shareholders' meeting.

In actively managing the Compartment, the investment manager uses a combination of market analysis and research to build a multistrategy portfolio that it believes offers an optimal, risk-adjusted return. It focuses on selecting strategies that have low correlation with each other as well as to traditional asset classes. It methodically exercises voting rights and may engage with the funds' managers in order to positively influence environmental, social, and governance (ESG) practices. The investment manager may invest in funds with any ESG profile.

# WHAT HAPPENS IF PICTET ASSET MANAGEMENT (EUROPE) S.A. IS UNABLE TO PAY OUT?

Pictet Asset Management (Europe) S.A. is a société anonyme and has been appointed as Alternative Investment Fund Manager ("AIFM") of the Fund. The Fund is also a société anonyme and its assets are segregated from those of the AIFM. The Fund has entrusted the Depositary Bank with the safekeeping of the its assets, which are kept separated from the Depositary Bank's assets. A default of Pictet Asset Management (Europe) S.A. will therefore have no impact on the value of your investment in the product.

# WHAT ARE THE COSTS?

# Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:
