MANAGER'S REPORT

Market review H1 2024

Global stock markets registered strong gains in H1 amid a resilient US economy and ongoing enthusiasm around Artificial Intelligence. Expectations of interest rate cuts also boosted shares although the pace of cuts is likely to be slower than the market had hoped for at the turn of the year. Bonds saw negative returns in the first half of the year.

The Federal Reserve (Fed) kept interest rates on hold at 5.25-5.5%. US inflation ticked up slightly to 2.5% year-on-year in February, from 2.4% in January, and remained steady towards the second quarter. Fed chair Jerome Powell said that the central bank will be "careful" about the decision on when to cut rates. That said, soft US consumer data meant that investors were slightly more hopeful for policy easing, and rates markets continue to point to two cuts by the end of the year.

The economic momentum of the first quarter of 2024 continued into the second, and the last three months were another positive period for equity markets. Initially, investors aggressively dialled back expectations for central bank rate cuts, as the US overheating worries that had taken root towards the end of the first quarter meant strong April data was poorly received by markets. But as the quarter progressed the worst of these worries abated, and soft-landing hopes revived. In Europe, economic momentum also remained positive as the effects of the cost-of-living shock continued to abate.

Companies exposed to artificial intelligence continued to outperform other areas of the market, and a strong earnings season for US tech companies meant global growth stocks were once again the top performing asset class. This performance was concentrated in the US, while value stocks outperformed growth stocks over the periodin Europe, Japan and the UK.

That said, US stocks were the best performers in the first half, with the S&P500 up 14.5% and the NASDAQ 18% at the end of June.

The US 10-year Treasury jumped from 3.87% at the end of Q4 2023 to 4.21% at the end of Q1 2024, and closing the first half at 4.15%.

Eurozone performed well too, in the period. Among the top gaining sectors were financials, consumer discretionary and industrials. Improvements in the economic outlook boosted more economically sensitive stocks while banks were supported by some announcements of improvements to shareholder returns. By contrast, utilities, consumer staples and real estate were the main laggards.

The European Central Bank (ECB) became the latest developed market central bank to cut interest rates. This move was heavily signalled prior to its June meeting, but stickier-than expected services inflation meant that the ECB was keen to stress that the path to any further policy normalisation is heavily data dependent. Despite the lowering of policy rates, the fallout from both the European parliamentary elections and the announcement of snap French elections meant that European sovereign yields rose, and European government bonds delivered negative returns over the quarter. Market concerns about the possible outcome introduced significant volatility, and the French equity market fell -6.4% in June.

Among the other equity markets, the Italian FTSEMIB and the German DAX were the best performers, jumping 9% in the half, while the French CAC40 closed the period 0.85% down.

UK equities rose too. Financials, industrials and the energy sector outperformed, along with some of the other economically sensitive areas of the market. Market expectations moved to price in a sooner-than-expected first UK interest rate cut as inflation undershot the Bank of England's (BoE) forecasts.

The Japanese Nikkei continued its exceptionally strong rally, closing the H1 18% up, in Japanese yen terms. The market's performance has been driven by large-cap stocks, particularly value stocks in sectors such as automotive and financials. Additionally, the global boom in artificial intelligence (AI) and semiconductors has also contributed to the rise in stock prices of semiconductor-related companies. On the other hand, domestic and defensive sectors, including land transportation, services, food, and pharmaceuticals, have lagged.

Moves by the Chinese authorities to support the real estate sector provided a boost to Chinese equity markets. This development, combined with strong performance from the artificial intelligence exposed Taiwanese stock market, helped Asia ex-Japan equities to deliver strong returns of 11% over the quarter.

Market Overview - An analysis of the overall market and general conditions for the period

The most significant macro news over the first quarter of the year has been continued disinflation progress, especially in Europe. The global growth picture continues to conform to the variable geometry with the U.S. showing clear 'exceptionalism'. There is huge uncertainty over the timing of the initial rate cut and both the pace and extent of the cutting cycle. The divergence in growth conditions and policy paths could set stage for some interesting market dynamics and developments. Over the second quarter, the macro news has been relatively modest. The lack of news, coming on top of the signals from earlier in the year that inflation could prove stickier, has encouraged central banks to stay cautious. For most economies, most of the economists have assumed growth and inflation to come in on the lower side of expectations, reflecting both fundamental and technical factors, expressing considerable skepticism about consensus forecasts for a weakening in the U.S. economy but we have now entered a window of plausibility for a U.S. slowdown, increasing the danger of inappropriately tight monetary policy. Global political risks have also risen, with surprises in elections in emerging markets and Europe. But the biggest political risk comes from the U.S. elections and how lax fiscal policy could place significant upward pressure on term premia as policy rates move lower. Markets had a very strong start to the year, reflecting a generally favourable growth/inflation mix in the US, the stimulative effects of technology innovation, and an abundance of liquidity worldwide which continues to work its way into equities. The gains were less narrowly focused than in some prior periods, both within the US, and globally, in that Japan was the best performing market worldwide while European equities rose by more than the equal-weighted S&P. Equity markets reached new highs in Q2, led by the US, which accounts for over 70% of the global index. The move was, however, slow and narrow, and was led by a few mega-cap names, mainly Nvidia and Apple, and a limited number of other 'gold rush' groups, such as, for example, any name or sector which might benefit from the data-centre build-out, anti-obesity agents, aerospace suppliers etc.; most other names were flat or down, so that the equal-weighted S&P fell by 2.8% versus the 4.3% gain of the cap-weighted index.

<u>Fund Performance - An analysis and detailed overview of the specific fund performance for the period and the reasons for same</u>

Within the Fund, equity and equity related strategies drove up the performance. Most of the gains came from long equity exposure to the equity indices in the first quarter, with its longs outperforming and shorts underperforming the index. In the second quarter, the market-relative performance of the Fund has been disappointing. The biggest contributory factor to this underperformance has been our low exposure to the small number of mega-cap stocks that have accounted for a clear majority of year-to-date index returns. Further, several mid-ranking names in the portfolio have, for a range of idiosyncratic reasons, lagged the market this year. Event Driven strategy performed well in the quarter too. Expectations for an M&A recovery in Q3 last year, and the increase in activity over the last six months has seen other commentators push the same narrative. Whilst the start of this M&A recovery has contributed to strong portfolio performance, it has not been the only reason for the strength. A more 'normal' functioning equity market, where equity investors are willing to more appropriately value companies, or in a takeover situation, fight to ensure companies are not sold on the cheap to acquirers, has resulted in the portfolio performing more in line with expectations. On the Convertible, performances remained muted during the quarter due to negative results both in January, due to the fact that, after valuations in the convertible market improved during December, in part due to a reversal in many equities and rates moving slightly higher, the convertible market took a breather and in April, when the highest delta exposure was hit by the equity markets' movements. Long Only was flat because of the long exposure to Healthcare sectors but low exposure to the biggest stocks in the sector, Eli Lilly and Novo Nordisk; in fact the equally weighted S&P healthcare index returned 1.3 percent in the first half compared to the 8 percent return for the cap weighted healthcare index. The extreme return concentration in a select few large-cap stocks was the biggest story in the first half of 2024. Macro was the biggest detractor of the Fund as the big event has been the backup in bond yields and in particular the backup in real yields. So real yields now are up close to around 2.5%, depending on which market you look at. And that is having ramifications for asset classes more generally.

Market Summary

A series of strong jobs reports and higher-than-expected inflation data in the US at the beginning of 2024 led to government bond yields moving higher, reversing the strong rally we saw at the end of 2023. This data was soon accompanied by hawkish rhetoric from the Federal Reserve (Fed) in the first quarter. Having begun the year pricing in as many as six rate cuts from the Fed in 2024, markets began to question whether there would be any at all.

Weaker economic data throughout the first half in Europe provoked the European Central Bank (ECB) to cut rates by 25bp to 3.75% at the beginning of June. However, the ECB remains data-dependent on any further moves down in the deposit rate as wage growth on the continent remains higher than expected.

After some more encouraging US inflation data in the second quarter, government bonds performed better with the 10-year US Treasury yield rallying from 4.70% to 4.40%. The market is expecting the Fed to make its first cut in September this year, meanwhile the market is split on whether the Bank of England will cut first in August or September; UK headline inflation is back to the 2% target, but services inflation remains sticky.

While volatility in government bonds has remained elevated, credit spreads have been very resilient and performed well so far this year. This has led new issuance levels to be high in 2024 but the market has been able to digest the supply comfortably. There has been some volatility created by political headlines with the announcement of snap French elections in June and the US Presidential election intensifying, however we expect economic data and central bank rhetoric will continue to be the main driver for markets heading into the second half of the year.

Fund Summary

The fund performed well in the first half of 2024, returning 4.24% for the period. Collateralised loan obligations (CLOs) and Additional Tier 1s (AT1s) were the biggest contributors to performance with both benefitting from higher starting yields. Meanwhile, government bonds were a small detractor from the fund's performance.

The team continued to keep liquidity high and credit quality robust. The managers reduced AT1s slightly after strong outperformance in the sector. Furthermore, they increased the duration of the government bond bucket slightly as yields went higher, having reduced it after the rally at the end of 2023. They also diversified the government bond bucket by switching some US Treasuries into German Bunds as German growth continued to falter in the first half.

Market Overview

In the first half of the year, European equity markets and the portfolio showed a robust performance in two distinct phases. The first quarter offered a favourable environment for growth investors. Positive data from the artificial intelligence (AI) giant Nvidia and optimistic investment plans from US hyperscalers, combined with expectations of a high pace of interest rate reductions, created a favourable environment for growth stocks, par- ticularly for the information technology (IT) sector. As the year progressed, it became clear that the downward path of interest rates was likely to be less smooth and slower than initially expected. Core inflation, especially in the US economy, fell, but at a more gradual pace than expected.

In June, the Bank of Canada and the European Central Bank were the first G7 central banks to cut interest rates. However, the rate cuts were made after the initially expected dates, while the Federal Reserve has not yet started its reduction cycle. Growth stocks therefore suffered in Q2 compared to value stocks due to their greater sensitivity to inte- rest rates, thus underperforming the portfolio despite the return of the quality factor in June, caused by the political turmoil in France.

Despite higher interest rates and high inflation, the International Monetary Fund expects the US economy to grow more than twice as fast as the other major developed countries this year. The IMF recently revised its forecast for US growth upwards to 2.7 per cent, compared to 0.8 per cent for Europe. Moreover, the consumer-driven strength of the US economy is supporting growth in the rest of the world.

Despite high inflation and the Federal Reserve's highest benchmark rate in 23 years, the US economy has shown remarkable resilience. Labour markets are robust, consumer spending robust and business fundamentals healthy.

Fund Performance

The positive intonation in the markets allowed a marked recovery of all assets, including those in the portfolio. However, the performance of the same produced returns in line with or even higher than the respective category funds.

It should be noted that the following actions were taken in the first part of the year:

- reduction of technology sector equity funds in favour of an increase in global equity funds of companies with a high dividend policy.neutralized the U.S. dollar's currency exposure as a result of the Fed's monetary policy spike.
- increase in bond assets, both in the government sector and in corporate and financial sector bonds (AT1).

In this context of a global slowdown and slow convergence of inflation towards the central banks' long-term objectives, financial markets have revised their monetary policy expectations for the last months of 2024 and are currently betting on a very substantial easing. It is therefore now clear that the focus of central bankers will shift from inflationary risks to risks to growth/employment and financial stability.

The fund at the end of June is 92% invested and has this diversification:

- The bond asset, expressed mainly in corporate and high-yield issuers in addition to emerging Bonds, through fund shares, totals 42%.
- Equity assets account for 50%.
- While the remaining 8% is in cash.

Market overview

Global equities had a positive first half of 2024 (MSCI ACWI +c10.3%), with a continuation of some of the major trends and themes seen during H2 2023. The dominating theme in developed markets of continuingly cooling inflation, while still maintaining strong labour markets and healthy economies has raised hopes that we are past peak borrowing costs and that, like we saw with the ECB in June, interest rate cuts are on the horizon. This backdrop provided equity markets with a reasonably stable macroeconomic environment throughout the first half of the year in which to perform. It hasn't been all smooth sailing though, with inconsistent economic data at times affecting future rate path expectations, as well as markets continuingly having to weigh up uncertainty around the state of the consumer, ongoing US/China geo-political tensions and on-going conflicts in the Middle East and Ukraine. The other big theme that has continued to dominate equity markets, the rise of generative AI, has also played a significant part in the positive performance seen in equity markets during H1. Within global equities, developed markets (MXWO +c10.9%) have outperformed emerging markets (MXEF +c6.1%), with China weakness particularly noteworthy (CSI300 +c0.9%, HSTECH -c5.6%). Within developed markets, Japan (NKY +c18.3%) with its weak currency, low interest rates, positive economic policies and structural reforms has been the best performer. Whist, the dominance of large-cap technology stocks and generative AI has played a significant role in the strong performance in the US, with the S&P 500 and NASDAQ indexes up by +c14.5% and +c17.0%, respectively. In Europe, the STOXX 600 was up a solid, but more moderate +c6.8%, due to less exposure to technology and growth-focused companies and experiencing volatility around snap elections in the UK and France, and European Parliamentary elections. The best performing sectors in Europe (SXXP) were Technology (+c16.9%) and Banks (+c15.2%), whilst Utilities (-c6.1%) and Real Estate (-c5.4%) performed worst.

Fund Performance

Our portfolio finished the first half of the year with a performance of +7.19%. The best-performing sector was Technology (+c4.29%); within the sector, Nvidia (+c2.2%) stood out as the top performer and major contributor to the fund's performance thanks to its dominant position as a key enabler of Generative AI. The next best performing sector was Capital Goods/Engineering and Manufacturing (+c1.73%%). UniCredit (+c0.8%) from our third best performing sector, Banks (+c0.99%), was another top performer with strength driven by strong earnings upgrades and announcing a significant capital return while still trading at a discount to book value. The worst-performing sectors were Metals, Mining and Paper (-c0.17%) and Travel Leisure and Hotels (-c0.11%). PVA TePla (-c0.12%) was our weakest performing stock, after seeing a softening in orders despite announcing strong results and having a large backlog of orders. Another weak performer was Argenx (-c0.11%). The first half of 2024 was largely characterised by the surge in AI, which had a notably strong positive impact on our portfolio thanks to being well positioned with our stock picks within the Technology sector. Heading into the second half of the year, we believe our portfolio is well balanced and positioned to manage any potential risks and challenges ahead, while also taking advantage of opportunities that may arise to improve our performance even further by year-end.

Market Overview

In the first half of the year global financial markets have shown significant volatility, influenced by macroeconomic uncertainties. The S&P 500 index closed the period up by 15.29%, mainly driven by the technology sector. However, major economies faced persistent inflation, which is still above the Federal Reserve 2% target in the United States, prompting the central bank to maintain tight monetary policy. Furthermore, economic growth in Europe slowed, with eurozone GDP increasing by just 0.3% in the second quarter of 2024. These factors continue to drive investor expectations, making the future direction of markets uncertain.

Fund Performance - analysis and detailed overview of the specific fund performance and the reason for same.

The fixed income portfolio maintained a stable performance and brought substantial carry. Having not taken exposure to duration in the first part of the half-year, it did not suffer the declines of the various government bonds. In terms of contribution, the following are distinguished: the BPER bond with a total return result greater than 20% and the convertible bond Evonik with a return above 10%. On the equity side, performances are more divergent. We have the gold sector, Alibaba, Raiway, BT which stand out in terms of contribution and the great diversification of the portfolio emerges despite a concentration of flows never seen before on the markets. The other telephone company, Telecom Itala, despite the concrete steps towards the spin-off of the network and the solution to the excessive debt, has not been able to find confirmation in prices. Gurit, the second derivative of the wind sector, is suffering from delays in renewable projects. The sub-fund posted a slightly negative performance over the period, -0.56% for the retail share class, -0.10% for the institutional share class and -0.49% for the premium share class.

The Plurima Mosaico Fund registered a 14.85% positive performance in the first half of the year (data for the Institutional Class) with an annualized volatility around 8.75%.

This performance has been achieved in an economic and market environment characterized by the debate on the evolution of growth, inflation and the main Central Banks' monetary policy. The first quarter saw an increasing focus on growth dynamics rather than inflation and monetary policy. Bonds underperformed, ranging from negative to positive depending on the riskiness of issuers and duration, after the rises at the end of 2023 probably driven by over-optimism and capital inflows rather than fundamentals. Equities, on the other hand, continued their bullish phase, initially driven by the technology sector and, since mid-February, with the spreading of positiveness to other sectors but always with a clear leadership of information technology and the Artificial Intelligence related themes. At the beginning of the second quarter, market dynamics were mainly driven by the evolution of inflation and macroeconomic data, and by the concern that central banks, primarily the Fed, would change their approach to monetary policy on the basis of still volatile inflation data, which seemed to put an end to the deflationary process that characterised 2023, and macroeconomic data denoting a stable cycle in the medium term. Interest rate futures began to price in a smaller scale of rate cuts by the US central bank and, above all, to postpone the start of the expansionary monetary policy until the second half of 2024 (and probably 2025).

Overall, the first half has been positive for equity markets and for all commodities except agricultural. The balance was more mixed for bond markets, where yield curves remained inverted, long-dated government bonds performed between unchanged and negative and the shorter-dated ones between unchanged and positive, while credit spreads narrowed.

The portfolio has been invested in equities, bonds, currencies, and commodities.

Equity exposure moved mainly between 30% and 80%, except for some tactical moves around 120% and below 10%, with an approach on stock selection based mainly on earnings growth and multiples justified by the companies' fundamentals. Regional asset allocation was focused mainly on Europe and the US, with tactical exposure, both on the long and short sides, in Japan, Australia and Canada.

Exposure to commodities has been kept between 4% and 8%, mainly through gold and copper, due to their inflation hedging, growth exposure and diversification characteristics.

In fixed income we invested mainly in short duration European Investment Grade and High yield euro corporate bonds, with maturities no longer than 2027, and developed markets government bonds. Overall the duration of the fixed income portfolio moved mainly between -1 and 1 year.

Currency diversification from the EURO has been mainly on USD, JPY, GBP, CHF and SEK. USD has been the biggest exposure in the period.

The main positive contribution to the performance came from the cash equity portfolio and from the equity derivatives, while no asset class gave a negative contribution.

Market Overview

In the first half of the year, European equity markets and the portfolio showed a robust performance in two distinct phases. The first quarter offered a favourable environment for growth investors. Positive data from the artificial intelligence (AI) giant Nvidia and optimistic investment plans from US hyperscalers, combined with expectations of a high pace of interest rate reductions, created a favourable environment for growth stocks, par- ticularly for the information technology (IT) sector. As the year progressed, it became clear that the downward path of interest rates was likely to be less smooth and slower than initially expected. Core inflation, especially in the US economy, fell, but at a more gradual pace than expected.

In June, the Bank of Canada and the European Central Bank were the first G7 central banks to cut interest rates. However, the rate cuts were made after the initially expected dates, while the Federal Reserve has not yet started its reduction cycle. Growth stocks therefore suffered in Q2 compared to value stocks due to their greater sensitivity to interest rates, thus underperforming the portfolio despite the return of the quality factor in June, caused by the political turmoil in France.

Despite higher interest rates and high inflation, the International Monetary Fund expects the US economy to grow more than twice as fast as the other major developed countries this year. The IMF recently revised its forecast for US growth upwards to 2.7 per cent, compared to 0.8 per cent for Europe. Moreover, the consumer-driven strength of the US economy is supporting growth in the rest of the world.

Despite high inflation and the Federal Reserve's highest benchmark rate in 23 years, the US economy has shown remarkable resilience. Labour markets are robust, consumer spending robust and business fundamentals healthy.

Fund Performance

Positive performance in the equity markets allowed almost all world indices to recover. The performance of the fund itself also produced returns in line with, or even better than, the respective category funds. During the first part of the year, the following actions were defined:

- In the second quarter, a gradual consolidation of returns was decided with the reduction of assets in the portfolio in favour of liquidity.
- Further increase in positions on the major U.S. indices, S&P 500and NASDAQ 100
- increased the funds deemed capable of handling all conditions in international markets and thus ensuring that the fund performs in line with its respective industry competi- tors.

In this context of a global slowdown and slow convergence of inflation towards the central banks' long-term objectives, financial markets have revised their monetary policy expectations for the last months of 2024 and are currently betting on a very substantial easing. It is therefore now clear that central bankers' attention will shift from inflationary risks to risks to growth/employment and financial stability.

We will use the volatility/reduction phases in the markets over the summer months to in- vest the current percentage in cash, again with an overweight in US equities.

The fund at the end of June was 83% invested, with the remaining 17% being cash and/ or monetary investments.

Net equity exposure moved between 35% and 120%, being on average 75% in the period. The geographic allocation was mainly in North America (between 50% and 60%), Western Europe (between 10% and 20%) and Asia Pacific (between 20% and 25%).

Currency diversification from the EURO has been mainly on USD, JPY, HKD, CHF, AUD and GBP. USD has been the biggest exposure in the period.

The positive contribution to the performance came entirely from the equity portfolio.

The Plurima Market Neutral UCITS Fund had a positive performance of 3.27% year to date since launching at the end of January.

In the first half of the year, markets reacted positively to the macroeconomic numbers leading to the potential first rates cut in September. Also the constant tailwind of interest in semi-conductors and AI in general led the S&P 500 TR index to produce again a strong performance, up 3.59%. In this context, it is interesting to stress the strong outperformance of large capitalization stocks vs. small capitalization stocks, which supported the fund positive performance. It is worth noting that with the continued interest in the key technology themes, most of the Magnificent 7 companies continued to show strength during this period. We can highlight that NVIDIA became for a few days the largest world capitalization after correcting and giving back the lead to Microsoft. NVIDIA is one of our core holdings, contributing on its own to approximately one third of the S&P500 performance in H1 2024.

The performance of S&P 500 sectors has been mixed as a reflection of the macroeconomic situation and expectations. Information Technology, Consumer Discretionary, and Communication Services have been up in H1 reflecting the high demand for Al and technology in general. This was captures by our net exposure to the Information Technology sector during H1.

The fund has used a financial derivative instruments (FDI) based approach to gaining long and short equity exposures as that continues to be the most efficient way of managing the investment strategy. The fund has been predominantly exposed to North America and retains a large portion of Liquid Assets to support the FDI approach alongside cash for margin requirements.

1. Principal Accounting Policies

The significant accounting policies followed by the Fund are as follows:

a) Basis of Accounting

The condensed financial statements for the period ended 30 June 2024 have been prepared in accordance with IAS 34, 'Interim Financial Reporting'.

The principal accounting policies applied in the preparation of these financial statements are consistent with the accounting policies applied in the preparation of the Audited Financial Statements for the year ended 31 December 2023, which were prepared in accordance with International Financial Reporting Standards ("IFRS").

The financial statements are prepared on a going concern basis.

2. Taxation

Under current Irish law and practice, on the basis that the Fund qualifies as an investment undertaking as defined in Section 739B of the Taxes Consolidation Act, 1997, it is not chargeable to Irish tax on its relevant income or relevant gains. However, tax can arise on the happening of a chargeable event in the Fund. A chargeable event includes any distribution or dividend payments to Unitholders, disposals, redemptions, cancellations, encashment or assignment of Units in the Fund. No tax will arise on the Fund in respect of chargeable events in respect of a Unitholder who is neither Irish resident nor Irish ordinarily resident at the time of the chargeable event provided that a relevant declaration in the form authorised by the Irish tax authorities is in place. In the absence of a relevant declaration, there is a presumption that the investor is Irish resident or Irish ordinarily resident.

Dividends, interest and capital gains (if any) which the Fund receive with respect to its investments (other than securities of Irish issuers) may be subject to taxes, including withholding taxes, in the countries in which the issuers of investments are located. Dividends received by the Fund from investment in Irish equities may be subject to Irish dividend withholding tax at the standard rate of corporation tax (currently 12.5%).

However, the Fund can make a declaration to the payer that it is a collective investment undertaking beneficially entitled to the dividends which will entitle the Fund to receive such dividends without deduction of Irish dividend withholding tax.

Pursuant to the Trust Deed, European and Global Investments Limited have been appointed Manager to the Fund. The Manager is responsible for the general management and administration of the Fund's affairs. The Manager is entitled to receive an annual fee, as set out below, out of that proportion of the Net Asset Value of a Sub-Fund attributable to the relevant Class, accrued daily and payable monthly in arrears at the following rates (plus VAT, if any);

The Manager is also entitled to be repaid out of the assets of the relevant Sub-Fund all of its administration and operational expenses. European and Global Investments Limited received a management fee of €1,662,656 (30 June 2023: €1,566,620) for the period of which an amount of €669,949 (31 December 2023: €613,573) was outstanding at the period end.

Where a Sub-Fund invests in one or more Sub-Funds of the same umbrella, the investing Sub-Fund may not charge an annual management fee in respect of that portion of its assets invested in other Sub-Funds.

- 5. The performance fee will be calculated and be taken into account in the calculation of the Net Asset Value per Unit on each Valuation Day. The "Benchmark" for the sub-funds except for PMNF is the value, on the last Valuation Day of each Performance Period which the Net Asset Value per Unit on the same day must exceed in order for a performance fee to be payable. For PMNF, the "Benchmark" is an interest rate benchmark in conjunction with the above Net Asset Value per Unit calculation. Included in that calculation shall be net realised and unrealised capital gains plus net realised and unrealised capital losses as at the end of the relevant period. As a result, performance fees may be paid on unrealised gains which may subsequently never be realised.

Trustee's Fees

Pursuant to the Trust Deed, CACEIS Bank, Ireland Branch acts as Trustee to the Fund. The Trustee shall be entitled to an annual trustee fee not to exceed 0.03% (actual fee 0.025%) of the NAV of the Sub-Fund (plus VAT, if any), accrued daily and payable monthly in arrears, subject to a minimum annual trustee fee of €10,000 (€14,000 for Fund of Funds) in respect of each Sub-Fund.

Trustee's fees for the period amounted to €58,114 (30 June 2023: €109,744) of which an amount of €93,739 (31 December 2023: €69,044) was outstanding at the period end.

The Trustee shall also be entitled to a custody fee, accrued daily and payable monthly in arrears based on the location of the assets under custody (which fee is inclusive of sub-custody fees) and will vary from 0.055% per annum of the value of the assets under custody and €18 per transaction (in certain countries such as the United States or Canada) up to 0.82% per annum of the value of the assets under custody (in certain countries such as Zimbabwe) and up to €300 per transaction (in certain other countries).

Administrator's Fees

CACEIS Ireland Limited acts as Administrator to the Fund. The Manager pays to the Administrator out of the assets of the Fund an annual administration fee not to exceed 0.045% of the Net Asset Value of the Fund, accrued daily and payable monthly in arrears (plus VAT, if any), which minimum fee will range from €20,000 to €26,000 per annum in respect of each Sub-Fund.

Where a Sub-Fund has more than one Portfolio Manager, the Manager pays to the Administrator out of the assets of the Fund an additional minimum fee of €2,000 per annum (plus VAT, if any) in respect of each additional Portfolio Manager in excess of one.

The Administrator shall also be entitled to be reimbursed out of the assets of the Fund for any third party expenses incurred on behalf of the Sub-Fund (plus VAT, if any) including, but not limited to, telephone, fax, cable and communications network, postage expenses, printing and publication costs of reports, circulars and any other documents.

Administrator's fees for the period amounted to €113,792 (30 June 2023: €108,265) of which an amount of €184,524 (31 December 2023: €136,870) was outstanding at the period end.

Pursuant to the Trust Deed, CACEIS Ireland Limited acts as the Transfer Agent to the Fund. The Manager shall pay to the Administrator out of the assets of the Fund a fee of €10,000 per annum in respect of each Sub-Fund (plus VAT, if any). This fee is subject to a maximum of 18 Sub-Funds and 4 classes per Sub-Fund.

Transfer Agent fees for the period amounted to €51,917 (30 June 2023: €51,523) of which an amount of €87,677 (31 December 2023: €66,249) was outstanding at the period end.

Research Fees

The Manager has agreed with the respective Portfolio Managers that research costs can be paid by the Fund in relation to Plurima 10 Convictions Fund, Plurima Mosaico Fund and Plurima Koine Thematics Fund.

4. Related Parties

IAS 24 'Related Party Transactions' requires the disclosure of information relating to material transactions with parties who are deemed to be related to the reporting entity.

The Fund and European Investment Consulting are considered related parties by virtue of Julian Alworth's role as a Director of the Manager and his employment by and part ownership of European Investment Consulting, a provider of consulting services to the Fund. Fees charged directly to the Fund for the period amounted to €26,507 (30 June 2023: €28,489). The service contract with European Investment Consulting ("EIC") was terminated as at 31 May 2024. A service contract with Silian Consulting SrI was entered into to replace EIC effective 1 June 2024.

European and Global Advisers LLP ("EGA LLP") is considered a related party as Julian Alworth is a Director of the Manager and partner in EGA LLP. See page 3 for a list of Sub-Funds for which EGA LLP is the portfolio manager.

The Manager administers the security lending scheme on behalf of the participating Sub-Funds, and receives a fee to cover expenses and time incurred in the process. Please see Note 15 for details.

Twenty Four Asset Management Limited is the Portfolio Manager of Plurima Apuano Flexible Bond Fund. This Sub-Fund has investments in the TwentyFour Income Fund Ltd and TwentyFour Select Monthly Income Fund Ltd, funds managed by Twenty Four Asset Management Limited, valued at €4,473,869, 4.86% of the Net Assets of the Sub-Fund (31 December 2023: €4,297,195, 4.49% of the Net Assets of the Sub-Fund). This would be considered a related party transaction by virtue of Portfolio Manager connection.

Connected Persons

In accordance with the requirements of Regulation 41(1) of the CBI UCITS Regulations, any transaction between the Fund and a Connected Person must be conducted at arm's length and in the best interests of the Unitholders where a "Connected Person" means "the Manager, the Trustee / Depositary, their delegates or sub-delegates and any associated or group company of such parties or their delegates or sub-delegates. The Manager is satisfied that there are arrangements in place (evidenced by written procedures) to ensure that the obligations set out in the CBI UCITS Regulations applied to all transactions with connected parties and that transactions with connected parties entered into during the period complied with the obligations set out in the CBI UCITS Regulations.

5. Efficient Portfolio Management

Where considered appropriate, a Sub-Fund may utilise financial derivative techniques and instruments for efficient portfolio management and/or to protect against foreign exchange risks, subject to the conditions and within the limits laid down by the Central Bank of Ireland. These techniques and instruments include, but are not limited to futures, options, swaps and forward foreign exchange contracts, details of which are disclosed in Note 11. Details of securities lending are provided in Note 15.

6. Financial Instruments and Associated Risks

The Fund's activities expose it to a variety of financial risks: market risk (including other price risk, interest rate risk and foreign currency risk), credit risk and liquidity risk.

The Fund is also exposed to operational risks such as settlement and custody risk. Custody risk is the risk of loss of financial assets and liabilities held in custody occasioned by the insolvency or negligence of the Trustee. Although an appropriate legal framework is in place that reduces the risk of loss of value of the financial assets and liabilities held by the Trustee, in the event of failure, the ability of the Trustee to transfer the financial assets and liabilities might be impaired.

A full description of the risks the Fund is subject to and how the risks are managed is disclosed within the annual audited financial statements for the year ended 31 December 2023.

7. Fair Value Measurements

IFRS 13, Fair Value Measurement, requires a fair value hierarchy for inputs used in measuring fair value that classify investments according to how observable the inputs are. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Fund. Unobservable inputs reflect the Fund's assumptions, made in good faith, about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The fair value hierarchy is categorised into three levels based on the inputs as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities (level 1);

Level 2 - Valuations based on quoted prices in markets that are not active or based on inputs other than quoted prices for which all significant inputs are observable, either directly (as prices) or indirectly (derived from prices) (level 2) and;

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement (level 3).

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics, and other factors. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement (lowest being level 3).

Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Fund. Unobservable inputs reflect Fund management's assumptions, made in good faith, about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The determination of what constitutes "observable" requires significant judgment by Fund management. Fund management considers observable data to be that market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by independent sources that are actively involved in the relevant market.

The categorisation of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to Fund management's perceived risk of that instrument.

Fair value is a market-based measure considered from the perspective of a market participant rather than an entity-specific measure. Therefore, even when market assumptions are not readily available, Fund management's own assumptions are set to reflect those that market participants would use in pricing the asset or liability at the measurement date. Fund management uses prices and inputs that are current as of the measurement date, including periods of market dislocation. In periods of market dislocation, the observability of prices and inputs may be reduced for many securities. This condition could cause a security to be reclassified to a lower level within the fair value hierarchy.

Valuation Techniques

When fair values of listed equity and debt securities, as well as publicly traded derivatives at the reporting date, are based on quoted market prices or binding dealer price quotations (official closing prices), without any deduction for transaction costs, the instruments are included within level 1 of the hierarchy. When the Fund has assets and liabilities with offsetting market risks, it uses mid-market prices as a basis for establishing fair values for the off-setting risk positions and applies the official closing prices to the net open position as appropriate.

7. Fair Value Measurements (continued)

Valuation Techniques (continued)

For all other financial instruments, fair value is determined using valuation techniques. Valuation techniques include net present value techniques, comparison to similar instruments for which market observable prices exist, options pricing models and other relevant valuation models.

The Fund uses widely recognised valuation models for determining fair values of over-the-counter derivatives. For these financial instruments, inputs into models are market observable and are therefore included within level 2.

The fair values of currency exchange contracts (forwards and swaps) are calculated by reference to current exchange rates for contracts with similar maturity and risk profiles.

The fair values of any investments in any open-ended collective investment schemes (CIS) are based on the net asset value (market value of the underlying CIS's assets less liabilities / number of shares) calculated by the administrator of the underlying CIS. The net asset value of the underlying CIS is adjusted for any factors that indicate that the net asset value per share, as calculated by the administrator of the underlying CIS, may not be the fair value. Investments in CIS are categorised in level 2, except for any ETF (Exchange Traded Funds), which may be classified as level 1.

For the Fund's assets and liabilities not measured at fair value at 30 June 2023 Cash at Bank and Bank overdraft are classified to level 1 and the remaining Fund's assets and liabilities are classified to level 2.

Level 3 securities valuations methodology

For Plurima Apuano Flexible Bond the Level 3 securities were valued by a competent person selected by the Directors and approved for such purpose by the Trustee with care and in good faith in accordance with the Fund's valuation policy. The approach taken to establish the probable realisation value for such assets is to use cost or last traded price.

The competent person for Plurima Apuano Flexible Bond Fund is Twenty Four Asset Management Limited.

For Plurima 10 Convictions Fund, Plurima Strategy Portfolio and Plurima Unifortune Global Strategy Fund the Level 3 investments were valued based on the assessment of the EGI Investment and Valuation Committee in consultation with the relevant Investment Managers and on the basis of the latest information available on these securities.

Plurima Strategy Portfolio and Plurima Unifortune Global Strategy

The Level 3 investments held by Plurima Strategy Portfolio and Plurima Unifortune Global Strategy are side pockets announced by H2O in October 2020 for a number of holdings of illiquid securities held in the H2O Multibonds, Adagio and Allegro funds. These illiquid securities comprised of various bonds issued by companies owned or associated with the Tennor Group, a company controlled by Lars Windhorst a well-known Germany financier. To our knowledge there is no independent third party valuations of these side pockets.

H2O Asset Management had provided indicative prices for the side pockets up until 28 February 2023 but this has now stopped.

Over four periods have passed since the situation occurred with no productive substantive action or favourable result.

Immaterial reimbursements were received in late January 2023 across the three side pockets and no further cash has been received.

The Investment and Valuation Committee of EGI has held monthly meetings at which the pricing of H2O has been discussed and approved.

There has been no recent guidance from H2O as to the underlying securities held in the side pocket, the indicative pricing has been stopped by H2O and it was advised that no further financial statements for the side pockets would be published as a result. The continuing absence of information has led the committee to consider that the probability of recovery and of further cash receipts from the side pockets is minimal.

This has resulted in the decision to price the three securities at zero as of 30 June 2024.

Plurima 10 Convictions

The Bioera SpA 6% 02/12/2021 bond issued amount is EUR 2.1m. At the end of 2021 the bond was being held at a price of 80 on the basis of an agreement with Bioera to repurchase it at this value.

However at maturity date no sale proceeds had been received and instead a press release from Bioera stated that the bondholders agreed to a payment moratorium until July 2022 which was subsequently extended to November 2022. The third and current moratorium was dated 30th November 2022 delays the maturity of the bond until 31st December 2023.

The third moratorium letter came with an agreement to pay an amount of EUR 75,000 to the bondholders by the end of December 2022 (amounting to approximately EUR 5,250 for the Fund. There was also an agreement to pay back the principal of the bond on a monthly basis starting from 31 January 2023 for a minimum of EUR 150,000 (approximately EUR 10,500 for the Fund's holding). The final part of the third moratorium letter was an agreement to use 80% of any capital raised by Bioera to pay back the bondholders.

Between the initial maturity date of December 2021 and November 2022, no payments in respect of the bond were received in relation to either income or capital.

The most recent financial statements as of 30 June 2023 show the company as loss-making for the period. Given the lack of transparent information in the public domain about the company, it proved difficulty to obtain any third party representation of the value of the bond during 2023 so far. The assets of the company appear to be able to cover the issued value of the bond, however the underlying assets appear to be illiquid or not immediately realisable.

A number of cash receipts were booked to the NAV relating to the payment terms contained in the moratorium delaying the maturity of the bond. Per the third moratorium letter terms the Fund received the promised payment as of the end of December 2022, however the following payment for the end of January 2023 was only a partial payment (EUR 1,725 received versus and EUR 10,500 expected). It was confirmed with the management of Bioera that they were unable to pay the full agreed amount due to internal cashflow issues. Bioera confirmed that Consob were aware of this. This lapse of the agreement follows the historical uncertainty associated with the bond.

The Portfolio Manager of the Fund (Olympia) have confirmed following a meeting with the management of Bioera that they have was a recent capital raise for EUR 400,000, 80% of which will be paid to bondholders as part of the moratorium. The fund is entitled to approximately 7% of this amount (relating to the nominal value of the bond held by the Fund compared to the total issued nominal).

Given the historical uncertainty with the bond and the fact that the maturity has been delayed three times alongside the already breached payment terms for the January 2023 principal payment, the Investment and Valuation Committee is of the opinion to continue to price the security at zero and book any cash into the NAV on a receipt basis. There has been no further cash received to the fund since January 2023.

The Investment and Valuation committee has considered these elements in its assessment of the value of the Bioera security.

The security was priced at zero for the period ended 30 June 2024.

Plurima 10 Convictions and Plurima Apuano Flexible Bond

There was a further Level 3 investment held by the Plurima 10 Convictions fund. This position was Novo Banco SA 2.62% relating to a liquidation claim on a historical Banco Espirito Santo bond holding that was originally due to mature in 2017 but defaulted when the bank collapsed in 2014.

The Portfolio Manager of Plurima 10 Convictions consider the bond to have no current recovery value and thus the security has been valued at zero as of the 30 June 2024. Recent attempts to sell the bond by the Portfolio Manager have not been successful.

It is noted that this security was also held on the Plurima Apuano Flexible Bond but was not a Level 3 security and was being priced by a market price source available to that fund. The EGI Investment and Valuation committee have acknowledged this pricing difference and the fact that each Portfolio Manager has a different outlook on the security. The price difference is considered immaterial on both funds.

15. Security Lending

16. Significant Events During the Period

Plurima Market Neutral UCITS Fund was launched as at 31 January 2024.

As at 15 March 2024, Unifortune Investment Management Limited terminated their Portfolio Management Agreement in relation to the Plurima Unifortune Global Strategy Fund. European and Global Advisers LLP was appointed as the Portfolio Manager of the sub-fund on the same date.

The Administrator (CACEIS Investor Services Ireland Limited) is a limited company wholly owned by CACEIS IS. Following the merger on 31 May 2024, all of the assets and liabilities of the Administrator were transferred to CACEIS Ireland Limited (CACEIS Ireland), a wholly-owned subsidiary of CACEIS. Following legal merger on 31 May 2024, CACEIS allocated all of its shares in CACEIS Investor Service Bank S.A. to CACEIS Bank. As result all assets and liabilities of CACEIS IS Bank (providing its services through Irish branch, CACEIS Investor Services Bank S.A, Dublin Branch) were transferred to CACEIS Bank (providing its services through Irish branch, CACEIS Bank, Ireland Branch).

From 28 May 2024 onwards, Sub-Funds with exposure to US securities will be required to settle any trades in such securities on a T+1 basis. As a result, post-trade processing time for US securities will be reduced, requiring greater volumes of overnight settlements. This may lead to an increase in failed trades, meaning that the reduction in credit and market risks as a result of a T+1 settlement cycle may increase regulatory and settlement risks for the relevant Sub-Fund. An increase in failed trades may also in turn result in more penalties under the CSDR which are payable by the party responsible for the failure.

There are no other significant events during the period which require disclosure here within.

17. Events After The Period End

An updated Prospectus was noted on 9 August 2024. The updates concerned the change of CACEIS Investor Services Ireland Limited to CACEIS Ireland Limited, new share classes and some other non-material amendments. Details of the new Prospectus are available from the website of the Management Company (www.egifunds.com) or from the Fund Administrator.

There are no other material significant events after the end of the financial period which would require adjustment to or disclosure in the financial statements.

18. Plurima Global Star Return Fund and TORO Fund

With effect from 2 November 2018, the Manager decided in line with the procedure laid out in the Prospectus to suspend the calculation of the net asset value and the issue and redemption of units in the Plurima Global Star Return Sub-Fund pursuant to its powers under Clause 17.03 (e) of the Trust Deed of the Fund.

On 1 February 2022, the Directors of the Manager formally made the decision that it was no longer practical or viable to continue to operate the Sub-Fund. The Directors of the Manager believed that it was in in the best interests of the unitholders of the Sub-Fund to terminate the Sub-Fund. This was communicated to the unitholders on 25 February 2022. Accordingly, pursuant to Clause 37.03 of the Trust Deed of the Fund, the Manager decided to terminate the Sub-Fund on 31 March 2022. Due to the termination, the sub-fund was not actively managed during the period.

With effect from 24 November 2020, the Manager decided in line with the procedure laid out in the Prospectus to suspend the calculation of the net asset value and the issue and redemption of units in the TORO Sub-Fund pursuant to its powers under Clause 17.03 (e) of the Trust Deed of the Fund.

The TORO Sub-Fund was consequently terminated as at 31 December 2020 and all shareholders were redeemed at this point.

The TORO Funds holds only a Lekta Therapy Limited bond. The bond was paying its coupons although it was deemed illiquid. However the coupon due in June 2022 was not paid. The Company is now in liquidation. The Manager is in contact with the liquidator and a claim has been registered.

19. Material Changes to Prospectus

There were no material changes to the prospectus during the period ended.
