What is this product?

The Fund does not have a maturity date, however the Directors or Trustee reserve the right to close the Fund in certain situations – more details are contained within the prospectus.

Objectives

The objective of the Fund is to seek to provide a total return primarily through investment in a portfolio of global property securities. The Fund will seek to achieve its objective by investing primarily in a global portfolio of publicly traded securities of companies engaged in the property industry or whose value is largely derived from property assets. The Fund's investment universe will include real estate investment trusts ("REITs") or non-REIT real estate companies in the United States, and similar structures in other areas of the world. The Fund is actively managed with reference to FTSE EPRA NAREIT Developed Index NTR (the "Index") on the basis that the Fund seeks to outperform the Index.

Intended Retail Investor

The Fund is intended for all investors seeking a total return over a long-term investment horizon. Investors should have the ability to bear losses up to the amount they have invested in the Fund. Investors should understand the risks involved and must have prior financial markets experience or knowledge to invest in this Fund.

Key Risks:


- There are specific risks associated with investing in the securities of companies in the real estate industry such as declines in the value of real estate, risks related to general and local economic conditions, overbidding and increased competition, increases in property taxes and operating expenses, changes in zoning laws, casualty or condemnation losses, variations in rental income, changes in neighbourhood values, the appeal of properties to tenants and increases in interest rates.
- The price of equity securities fluctuates based on changes in a company's financial condition, overall market and economic

conditions and market sentiment, resulting in an increased potential for volatility.

- Due to the underlying real estate assets held in REITS, the liquidity of these securities is typically less than other equity securities.
- The market value of debt securities is affected by changes in prevailing interest rates. The Fund may also be exposed to credit and default risk by investing in such securities. The default risk increases for below investment grade debt securities.
- Shares of small capitalisation companies may be less liquid than in large capitalisation companies. Smaller companies may also have higher insider ownership, leaving a smaller free-float for external shareholders.
- The Manager integrates sustainability risks into the investment processes for the Fund in relation to risk management and decision making. This means sustainability factors are considered as part of the investment process which may carry the risk that the Fund's performance may be negatively impacted due to restrictions placed on its exposure to certain sectors or types of investments as a result.
- The Fund may utilise a number of derivative instruments in managing the Investment Objective of the Fund. The primary risks associated with the use of such instruments are credit risk, counterparty risk, liquidity risk, legal risk and collateral risk.
- The value of an investment may fluctuate due to changes in exchange rates between currencies and may or may not be hedged back to the Fund's base currency.
- Fees and/or distributions may be paid out of the capital of the Fund, which has the effect of lowering the capital value of investor's holdings in the Fund and limiting the potential for future capital growth.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the PRIIPs manufacturer to pay you.

If the product currency differs from your investment currency, the following applies: Be aware of currency risk. Performance Scenarios
