What is this product?

TYPE OF PRODUCT

The product is a sub-fund of Protea Fund, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the board of directors may also propose to dissolve a sub-fund at a general meeting of that sub-fund.

OBJECTIVES

Objectives and investment policy

The objective of the Sub-Fund is to achieve capital appreciation over the medium to long-term by investing its assets across all the asset classes based on a macro analysis.

The Sub-Fund intends to invest mainly in:

- all kinds of securities, with fixed or variable income, including, but not limited to, equity, bonds (including but not limited to zerocoupon, indexed or convertible bonds), commodity related products (considered as eligible assets under the investment restrictions),
- all kind of financial derivative instruments as described below,
- Money Market Instruments and,
- structured products (as described in the prospectus).

There is no limitation or restriction on with respect to the asset allocation or sectorial and geographical exposure (including emerging markets). Depending on financial market conditions, a particular focus can be placed in a limited asset class, a limited type of securities, a single country, a small number of countries, or a particular geographic region.

Within the limits in the prospectus, the investment policy can be achieved indirectly via investments in other UCITS and/or UCIs.

If the investment manager considers this to be in the best interest of the sponsor shareholders, the Sub-Fund may also hold, on a temporary basis, up to 100% of its net assets, in liquidities such as among others cash deposits, money market funds and Money Market Instruments.

Derivatives For hedging and for any other purposes, the Sub-Fund may use financial derivative instruments within the limits and descriptions set out in the prospectus. The use of derivative instrument may increase leverage, imply additional costs and risks.

Benchmark The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital, for receiving regular income and who wish to hold their investment over 4 years.

Asset segregation The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

Dealing The NAV of the Sub-Fund shall be calculated on the first Business Day of each month as well as on the fifteenth calendar day of each month based on the pricing of the preceding bank business day ("the Valuation Day"). The cut-off time to submit subscriptions and/or redemptions orders is 4 p.m. Luxembourg time one business day before the Valuation Day.

Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target class or sub-fund are fulfilled with respect to this sub-fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. The risk indicator assumes you keep the product for 4 years.

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 4 years.

The RHP was chosen to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The NAV of the Sub-Fund shall be calculated on the first Business Day of each month as well as on the fifteenth calendar day of each month based on the pricing of the preceding bank business day ("the Valuation Day"). The cut-off time to submit subscriptions and/or redemptions orders is 4 p.m. Luxembourg time one business day before the Valuation Day.
