What is this product?

TYPE OF PRODUCT

The product is a Sub-Fund of PWM Funds, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However if the net assets of the sub-fund are at any time below EUR 5 million or the equivalent thereof in the currency of the relevant sub-fund, or if a change in the economic or political situation relating to the sub-fund would justify such liquidation or if it is required by the interests of the shareholders of the sub-fund, the board of directors may decide to liquidate the sub-fund and redeem all outstanding shares.

OBJECTIVES

Objectives and investment policy

The objective of the Sub-Fund is to achieve - through investments in listed real estate and fixed income securities - a risk and return profile comparable with the broader real estate market.

The Sub-Fund will mainly offer exposure to equity and equity related securities (such as closed-ended real estate investments trusts (REITs), depositary receipts) issued by companies that are engaged principally in the real estate industry.

The Sub-Fund will mainly invest:

- directly in the securities mentioned in the previous paragraph; and/or
- in undertakings for collective investment (UCIs) having as main objectives to invest or grant an exposure to the above mentioned securities; and/or
- in financial derivative instruments (such as but not limited to futures and options) having as underlying or offering exposure to the above mentioned securities.

The choice of investments will neither be limited to a geographic sector (including emerging countries) or a given currency. However, depending on market conditions, this exposure may be focused on one country or on a limited number of countries and/or one currency.

However, the Sub-Fund may not invest more than 20% of its net assets in emerging countries.

On an ancillary basis, the Sub-Fund may invest in any other type of eligible assets, such as debt securities, structured products, cash, money market UCIs and money market instruments.

It is understood that the Sub-Fund will not invest more than

- 20% of its net assets in asset-backed securities and mortgage-backed securities;
- 10% of its net assets in non-investment grade debt securities.

If the investment manager deems it necessary and in the best interest of the shareholders, on a temporary basis, the Sub-Fund may hold up to 100% of its net assets in liquidities, including deposits, money market instruments and money market UCIs.

Derivatives For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments traded on a regulated market and/or over-the-counter.

Nevertheless, in normal market conditions, the investment manager intends to use futures, options, swaps and currency derivatives.

Benchmark The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by the Central administration. This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is reserved for institutional investors. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 3 years.

Asset segregation The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target class or sub-fund are fulfilled with respect to this Sub-Fund, on the basis of their respective Net Asset Value calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to this Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
