What is this product?

TYPE OF PRODUCT

The product is a sub-fund of Quaero Capital Funds (Lux), an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

The Sub-Fund is established for an unlimited duration. However if, for any reason, the net assets of the Sub-Fund or of any Class or Sub-Class fall below the equivalent of EUR 5,000,000, or if a change in the economic or political environment of the Sub-Fund, Class or Sub-Class may have material adverse consequences on the Sub-Fund, Class or Sub-Class' investments, or if an economic rationalisation so requires, the board may decide on a compulsory redemption of all Shares outstanding in the Sub-Fund, Class or Sub-Class on the basis of the Net Asset Value per Share (after taking account of current realisation prices of the investments as well as realisation expenses), calculated as of the day the decision becomes effective.

Objectives and investment policy

The Sub-Fund's investment objective is to seek long-term capital appreciation through responsible investment in equities of U.S. (United States of America) companies, mainly which have favourable environmental, social and governance ("ESG") characteristics.

The Sub-Fund will mainly invest in equities and equity-related securities (such as depositary receipts and closed-end real estate investment trusts (REITs)) of companies across all market capitalizations:

- with what the sub-investment manager believes is a relatively low price/earnings ratio,

- that meet a minimum rating on MSCI's proprietary ESG ranking system (or other equivalent ranking system), and*
- which are domiciled, headquartered or exercise their main activity in the United States of America (U.S.).

For about one third of its net assets, the Sub-Fund can:

- invest in equities and equity-related securities other than those above-mentioned, and in undertakings for collective investment (UCIs); and

- for treasury purposes (in normal market conditions), invest in money market instruments, money market UCIs, and in deposits.

However, the Sub-Fund will not invest more than 10% of its net assets in UCIs.

In addition, the Sub-Fund can hold cash for the time necessary to proceed to re-investments, up to 20% of its net assets.

Except the geographical focus on the U.S., the choice of investments will not be limited by economic sector or the currency in which investments will be denominated. The Sub-Fund may invest up to 30% of its net assets in non-U.S. equities.

If the sub-investment manager considers it to be in the best interests of the shareholders, the Sub-Fund may also hold up to 100% of its net assets in cash, money market UCIs and money market instruments, on a temporary basis and for defensive purposes.

Derivatives The Sub-Fund is authorised to invest in financial derivative instruments, for hedging and for investment purposes.

Benchmark The Sub-Fund is actively managed. The Sub-Fund uses the index Russell 1000 Value Net Total Return USD for performance comparison only. The Sub-Fund does not track the index and can deviate significantly or entirely from the index.

ESG Information The Sub-Fund integrates environmental and social characteristics and is categorized as a SFDR Article 8 Product.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is USD.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is reserved to initial investors. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

Dealing The NAV for the Class is calculated on each business day ("the Valuation Day"). The cut-off time to submit subscription orders is 12 p.m., on the relevant Valuation Day. The cut-off time to submit redemption orders is 12 p.m., on the relevant Valuation Day.

Switching Shareholders may apply for any share of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target class are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
