Fund investment policy report

The reporting period was overshadowed by a challenging macro environment in the Eurozone. On the one hand, the economy stagnated, on the other hand, inflation proved to be much more stubborn than expected, compelling the European Central Bank (ECB) to maintain a restrictive course. The central bank, which for too long had adhered to its expansionary monetary policy, remained true to its pattern and raised the key interest rates at each of its 5 meetings until the end of July 2023. This charted the course for euro government bond yields, which continued to rise, albeit much slower than expected at +0.3 %. For the most part, risk premiums on corporate bonds were quite stable. As of the reference date, there was effectively no change over the period under review. Risk premiums temporarily widened by about 150 basis points in March 2023. At the time, the dominant market topic was the collapse of individual regional banks in the USA. Once a systemic banking crisis was averted, the credit markets recovered most of the correction by the end of July 2023. All in all, the euro high-yield market remained in good shape in the first half of the calendar year, with yields substantially above those of euro bond categories with high credit ratings. As a defensive high-yield product, the fund remained true to its tried and tested strategy. Its defensive stance is best reflected by the rating structure: The fund strategically adds a small portion of investment-grade issuers, which most recently stood at 15 %. On the other side of the spectrum, companies at high risk of default are given a strategic underweight. The share of debtors with "C" ratings was routinely in the low single-digit percentage range, and hence below the level of the overall market. Although this strategy affects current interest income in the short term, it reduces default costs in the longer term. At the end of the reporting period, the portfolio's average rating of BB was in the solid sub-investment grade range, 1 notch above the average rating of the market as a whole. For the most part, the average portfolio duration was just above 3 years. This is roughly in line with the average residual maturity of the high-yield market. The portfolio retains a broad diversification and held more than 300 individual investments at last count. With around 220 issuers, the average weight per issuer is just under 0.5 %. At +2.3 % after costs, the fund posted a satisfactory performance. Active management generated additional income of +0.6 %, which primarily derived from individual stock decisions. The strategic orientation (underweight of issuers with C ratings) also had a positive effect.

At 7.3 %, the average return across the portfolio is roughly the same as at the beginning of the financial year. We assume that the pressure from rising Bund yields will ease significantly; on the other hand, the market valuation involving a yield premium of around 4.5 % no longer looks cheap.

Securities lending transactions were entered into in order to generate additional income.

Under the master agreement on securities lending transactions concluded between the management company and Raiffeisen Bank International AG, Raiffeisen Bank International AG is obliged to provide collateral for loaned securities. Bonds, equities and units in investment funds are permitted as collateral. The bonds used as collateral may be issued by sovereigns, supranational issuers and/or companies etc. No stipulations apply in relation to the terms of these bonds. Within the scope of provision of collateral, pursuant to § 4 of the Austrian Securities Lending and Repurchase Agreement Ordinance (Verordnung zu Wertpapierleih- und Pensionsgeschäften, WPV), diversification and correlation with risk diversification achieved through quantitative issuer limits in particular and appropriate liquidity for collateral for the purpose of tradability and realizability will be ensured. This collateral will be valued on each banking day, subject to an add-on compared to the valuation of the securities loaned from the fund in accordance with provisions of EU Regulation 575/2013 (CRR). For bonds, this add-on will be determined on the basis of the credit rating of the issuer and the remaining term of the bond and will amount to no less than 0.5 %. For equities and units in investment funds, this add-on will amount to 10.607 %. 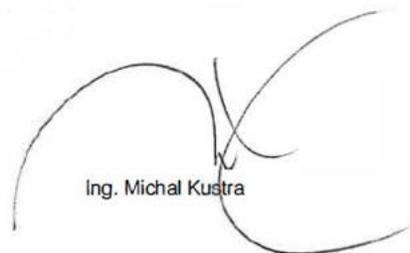
