Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Product: Red Stone Balanced Fund - CHF -

Manufacturer: LLB Fund Services AG

The fund is a OGAW of the umbrella funds (Red Stone Fund) launched in Liechtenstein. It is managed by LLB Fund Services AG (hereafter "we").

Hints:

- A prospectus and semi-annual and annual reports are prepared for the umbrella fund, in which the individual sub-funds are presented separately.
- Because each sub-fund is a separate legal fund, the assets and liabilities of each sub-fund are legally separate; due to the segregation of the assets and liabilities of each sub-fund, there will be no impact on the respective investors.
- Shares in one sub-fund cannot be exchanged for shares in another sub-fund.

I. What is this product?

Type: The fund is a OGAW of the umbrella funds (Red Stone Fund) launched in Liechtenstein.

Term: The Fund does not have a pre-determined maturity, it is established for an indefinite period. For the recommended holding period, see section "V. How long should I hold it and can I take my money out early?". The Fund may be dissolved by resolution of LLB Fund Services AG. This is particularly the case if significant changes in the actual circumstances occur that justify dissolution. The Fund must be dissolved by operation of law if it falls below the minimum capitalisation required by law.

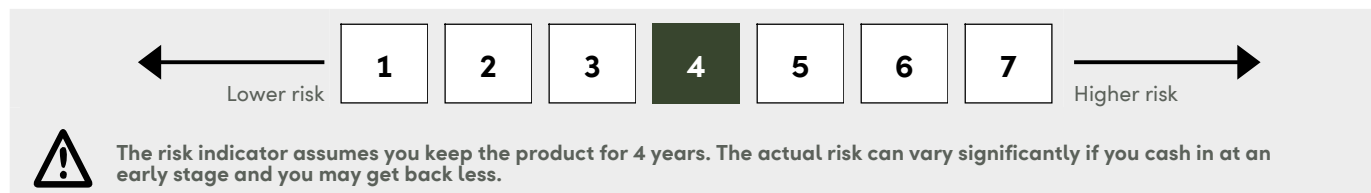
Objectives: The investment objective of the Sub-Fund is primarily the preservation and long-term growth of capital in real terms through interest and dividend income and through capital appreciation. This is an actively managed Sub-Fund without reference to a benchmark. No assurance can be given that the investment objective will be achieved. The Sub-Fund follows a balanced investment strategy with Euro as reference currency. The currency designation contained in the name of the Sub-Fund indicates only the currency in which the Net Asset Value of the Sub-Fund is calculated and not the investment currency of the Sub-Fund. Investments are made in the currencies that are best suited to the performance of the sub-fund. Investments may be made globally, in all freely tradable currencies and in all economic sectors which, in the opinion of the Asset Manager, are particularly suitable for the appreciation of the Sub-Fund's assets. In accordance with the principle of risk diversification, the sub-fund invests in a broadly diversified securities portfolio consisting of equities, bonds and other investments permitted within the framework of the investment regulations and investment restrictions set out herein. The sub-fund invests a minimum of 20% and a maximum of 70% of its assets worldwide at all times, directly or indirectly, in equities or equity-like securities in all industries and sectors, including real estate equities. When selecting strategic equity positions, the asset manager attaches great importance to the quality of the management, a solid earnings situation, the existing growth potential and a strong market position.

The depositary of the fund is Liechtensteinische Landesbank AG. The Prospectus and the current annual and semi-annual reports, the current unit prices and further information on the Fund can be found free of charge in the legally-binding language according to the Prospectus at www.llb.li.

Intended retail investor: The fund is aimed at retail investors who pursue the objective of general asset accumulation / asset optimisation and have a medium-term investment horizon. This product is a fund for investors with no or little knowledge and / or experience in financial products. The investor can bear losses up to the complete loss of the capital invested and does not attach any importance to capital protection.

II. What are the risks and what could I get in return?

Summary Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions are could impact the capacity of the product manufacturer to pay you.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor / and includes the costs of your advisor or distributor. III. What happens if LLB Fund Services AG is unable to pay out?

The default of LLB Fund Services AG has no direct impact on your payout, since the legal regulation stipulates that in the event of insolvency of LLB Fund Services AG, the special assets are not included in the insolvency estate, but remain independent.

IV. What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return).
For the other holding periods we have assumed the product performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 9.8 % before costs and 6.9 % after costs.

V. How long should I hold it and can I take my money out early?

Recommended holding period: 4 years

This product has no minimum holding period. It is suitable for medium-term investments. You should therefore be prepared to remain invested with your investment for at least 4 years. However, you can return your investment on any Liechtenstein banking day and without penalty.
