What is this product?

Type:

Naamloze Vennootschap (N.V.) – An investment company with variable capital incorporated under Dutch law.

Objective:

Rolinco is an actively managed fund that invests worldwide in equities from developed and emerging countries. The selection of these stocks is based on a fundamental analysis. The fund's objective is to achieve a better return than the index. The fund focuses on growth by investing in promising long-term growth trends. It also invests in five different and independent top-down trends: the digital world, the emerging middle class, resource stewardship, connected enterprise, and healthy aging. Within the identified growth trends, the fund mainly invests in shares of companies that have the purest possible exposure to the trends. The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions.

The Fund does not use a Benchmark for its investment policy. The Fund is actively managed and uses the MSCI All Country World Index for comparison purposes However, although securities may be components of the Benchmark, securities outside the Benchmark may be selected too. The Manager has discretion over the composition of the Portfolio subject to the Investment Guidelines.

The reference index is a broad market weighted index that is not consistent with the environmental, social and governance characteristics promoted by the Fund. The methodology used for the calculation of the reference index can be found on the website of the benchmark administrator (MSCI).

Currency Risk: The fund can engage in currency hedging transactions.

Dividend policy: Distributing - Annually

Intended Retail Investor: The Fund is suitable for Investors who seek ESG considerations to be integrated as binding element in the investment process, while still seeking optimum returns.

The Fund is suitable for investors who see funds as an easy way to benefit from developments in the stock markets. Investors must be able to absorb sizeable temporary losses and should have experience with volatile products. The Fund is suitable for investors who can afford to set aside the capital that they have

invested in the Fund for at least seven years.

Product Term: The fund does not have a fixed term of existence or maturity period. In certain circumstances, as described in the fund documentation, the fund may be unilaterally

terminated following written notice to shareholders subject to compliance with the fund documentation and applicable regulation.

What are the risks & what could I get in return?



The risk indicatior assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Be aware of currency risk. What happens if Robeco is unable to pay out?

The fund's assets are held separately from Robeco Institutional Asset Management B.V. (the "Manager"). A pay-out of the fund's assets is thus not affected by the financial position or potential default the Manager. The financial instruments in the portfolio of the fund are placed in custody with J.P. Morgan SE, Amsterdam Branch (the "Depositary"). The fund runs the risk that its assets placed in custody may be lost as a result of the liquidation, insolvency, bankruptcy, negligence of, or fraudulent activities by, the Depositary. In that case the fund may suffer a financial loss. However this risk is mitigated to some extent as the Depositary is required by law to keep the fund's assets separate from its own assets. An investor compensation or guarantee scheme is not applicable in case of such financial loss.

What are the costs?
