The Austrian Financial Market Authority (FMA) is responsible for supervising the Management company in relation to this Key Information Document.

Erste Asset Management GmbH is a management company within the meaning of the InvFG 2011 that is authorised in Austria and an alternative investment fund manager within the meaning of the AIFMG and is regulated by the FMA.

This Fund is authorised in Austria.

What is this product?

Type

The product is pension investment fund (AIF, fund) pursuant to \$\$ 168 to 174 Investment Fund Act 2011 (InvFG) in conjunction with \$ 108b Income Tax Act (EStG) in conjunction with the Alternative Investment Fund Managers Act (AIFMG). The Fund is a portfolio of assets with no legal personality that is divided into equal units represented by securities and that is collectively owned by all unit-holders.

Term

The Fund was established for an indefinite period of time.

The Management Company may terminate the management of the Fund or merge the Fund with another fund, both in compliance with the applicable legal regulations (see the Information for Investors in accordance with § 21 AIFMG, section II, item 7). If the unit-holders redeem all units in the Fund, the Fund will also be terminated.

Objectives

RT PIF traditionell is a state-subsidised pension investment fund and serves the purposes of private retirement investment.

The Fund aims to achieve capital growth and/or continuous returns.

The Fund invests at least 5% and up to 49% of its assets in international stocks and at least 51% of its assets in EUR-denominated bonds (partial debentures, public notes, convertible bonds, covered bonds, local-authority bonds, and Austrian federal treasury bonds). In addition, a limited volume of securities can be purchased that reflect the performance of an equities basket. The Fund invests predominantly in bonds. Securities from issuers registered outside of the EEA can account for up to 50% of the fund assets.

The Fund can invest up to 100% of its assets in units of other investment funds that in turn invest at least 5% and up to 49% of their assets in international stocks and at least 51% of their assets in EUR-denominated bonds (partial debentures, public notes, convertible bonds, covered bonds, local-authority bonds, and Austrian federal treasury bonds).

Transferable securities (including securities with embedded derivative financial instruments) may comprise up to 100% of the fund assets.

In accordance with the Fund Rules that have been approved by the Austrian Financial Market Authority, the Fund intends to invest more than 35% of its assets in securities and/or money market instruments of Member States, regional authorities, or public international bodies. A detailed list can be found in Article 3 of the Fund Rules or in item 12 of the Information for Investors pursuant to § 21 AIFMG.

Units in investment funds (UCITS, UCI) may comprise up to 20% of the fund assets per individual issue and may comprise up to 100% in aggregate total, provided that the target funds themselves (UCITS, UCI) do not invest more than 10% of their fund assets in units of other investment funds.

Units in UCI may make up no more than 30% of the fund assets in total.

Derivative financial instruments and securities with embedded derivative financial instruments may only be purchased for hedging purposes.

The Fund employs an active investment policy and is not oriented towards a benchmark. The assets are selected on a discretionary basis, and the Management Company's degree of freedom is not limited.

Intended retail investor

This product is intended for investors with basic knowledge and with no or only limited experience with investing in funds, who wish to increase the value of their investment over the recommended holding period and/or who are seeking regular returns, and who are also willing to accept a potential financial loss in terms of their originally invested capital.

Additional information

You can demand the redemption of your fund units on any Austrian exchange trading day with the exception of bank holidays.

The Management Company can suspend redemption if this is deemed prudent based on exceptional circumstances.

The risk indicator assumes you will keep the product for at least 6 years.

What happens if Erste Asset Management GmbH is unable to pay out?

The Fund is a portfolio of assets that is segregated from the assets of the Management Company. There is thus no risk of default in terms of the Management Company (for example in the event that it becomes insolvent). The unit-holders are joint owners of the assets of the Fund. The Fund is not subject to any legal or other deposit guarantee scheme.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 6 years
