What is this product?

Type

This is an open ended UCITS fund.

Term

There is no maturity date of the fund.

Investment objective

The fund aims to provide a positive return after fees have been deducted over a three year period by investing in equities worldwide, including emerging markets.

The fund is actively managed and invests both long and short in companies. The fund may invest in equities, bonds, derivatives and other financial instruments and hold cash.

The fund invests directly by purchasing physical holdings and/or indirectly through derivatives. The fund may use leverage and will typically be netlong equities.

The fund may invest up to 10% of its assets in open ended investment funds. The fund may exceptionally hold up to 100% of its assets in cash.

The fund invests directly by purchasing physical holdings and/or indirectly through derivatives. The fund may use leverage and will typically be net-long equities.

Recommendation: Investors should seek independent advice and satisfy themselves that they have an understanding of the techniques employed by the manager.

The fund may use derivatives, long and short, with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

Benchmark: The fund's performance should be assessed against its target benchmark, being to provide a positive return over a three year period and compared against the MSCI World (Net TR) Local Currency Index and Euro Short-Term Rate +1.00%. The comparator benchmarks are only included for performance comparison purposes and do not have any bearing on how the investment manager invests the fund's assets. In relation to the MSCI World (Net TR) Index the fund's investment universe is expected to overlap directly or indirectly to a limited extent with the components of the comparator benchmark. Dealing Frequency: You can buy and sell shares weekly on Wednesday (or the next business day if a Wednesday is not a business day) and on the last business day in a month.

Distribution Policy: This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. This investment should form part of a varied investment portfolio. This product is suitable for general sale to retail and professional investors through all distribution channels with or without professional advice.



What are the risks and what could I get in return? Risks

Performance Scenarios
