You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

This is an open ended UCITS fund.

Term

There is no maturity date of the fund.

Investment objective

The fund aims to provide income and capital growth in excess of the MSCI World (Net TR) Index after fees have been deducted over a three to five year period by investing in equities of companies worldwide.

The fund is actively managed and invests at least two-thirds of its assets in equity and equity related securities of companies worldwide.

The fund will invest in a diversified portfolio of equity and equity related securities whose dividend yield in aggregate is greater than the average market yield. Equities with below average dividend yield may be included in the portfolio when the investment manager considers that they have the potential to pay above average yield in future.

The fund will not be managed for yield alone: total return (dividend yield plus capital growth) will be equally important.

The fund may invest directly in China B-Shares and China H-Shares and may invest up to 10% of its assets (on a net basis) directly or indirectly (for example via participatory notes) in China A-Shares through Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and shares listed on the STAR Board and the ChiNext. The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in appendix I).

The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying

Benchmark: The fund's performance should be assessed against its target benchmark, being to exceed the MSCI World (Net TR) Index and compared against the MSCI World Value (Net TR) index and the Morningstar Global Income Equity Category. The fund's investment universe is expected to overlap to a limited extent with the components of the target benchmark and the MSCI World Value (Net TR) index. The comparator benchmarks are only included for performance comparison purposes and do not determine how the investment manager invests the fund's assets. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the target benchmark or the MSCI World Value (Net TR) index. Dealing Frequency: You may redeem your investment upon demand. This fund deals daily.

Distribution Policy: This share class pays a monthly distribution at a rate of 3.50% per annum of the value per share plus a premium when the Australian dollar interest rate is higher than the fund's base currency (US dollar) interest rate and minus a discount when the Australian dollar interest rate is lower. The distribution policy is kept under review.


The level of premium or discount is determined by differences in Australian dollar and US dollar interest rates and is not part of the fund's objective or investment policy.

Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. This investment should form part of a varied investment portfolio. This product is suitable for general sale to retail and professional investors through all distribution channels with or without professional advice.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 3 years.
