You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

This is an open ended UCITS fund.

Term

There is no maturity date of the fund.

Investment objective

The fund aims to provide capital growth in excess of the MSCI Nordic Micro Cap (Net TR) Index after fees have been deducted over a five to seven year period by investing in equities of micro-sized Nordic companies.

The fund is actively managed and invests at least two-thirds of its assets in equities of micro-sized Nordic companies. These are companies which, at the time of purchase, are considered to be in the bottom 10% by market capitalisation of the Nordic equities market. Up to 10% of the fund can be invested in unlisted securities.

Portfolio construction is based on fundamental research, with a bias towards investing in well-managed, innovative businesses that can generate cash and grow sustainably in the long term.

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in appendix I of the prospectus).

The fund may use derivatives with the aim of reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

Benchmark: The fund's performance should be assessed against its target benchmark being to exceed the MSCI Nordic Micro Cap (Net TR) Index and compared against the Morningstar Nordic Small/Mid-Cap Equity Category. The fund's investment universe is not expected to overlap materially with the components of the target benchmark. The comparator benchmark is only included for performance comparison purposes and does not determine how the investment manager invests the fund's assets. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the target benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. Dealing Frequency: You can buy and sell shares weekly on Wednesday (or the next business day if a Wednesday is not a business day) and on the last business day in a month.


Distribution Policy: This share class pays a semi-annual distribution at a fixed rate of 3% per annum of the value per share. The distribution policy is kept under review.

Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. This investment should form part of a varied investment portfolio.
