# What is this product?

#### Type

This is an open ended UCITS fund.

#### Term

There is no maturity date of the fund.

#### Investment objective

The fund aims to provide capital growth in excess of the MSCI Nordic Micro Cap (Net TR) Index after fees have been deducted over a five to seven year period by investing in equities of micro-sized Nordic companies.

The fund is actively managed and invests at least two-thirds of its assets in equity and equity related securities of small and micro-sized Nordic companies. These are companies which, at the time of purchase, are considered to be in the bottom 10% by market capitalisation of the Nordic equities market. Up to 10% of the fund can be invested in unlisted securities.

Portfolio construction is based on fundamental research, with a bias towards investing in well-managed, innovative businesses that can generate cash and grow sustainably in the long term.

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in appendix I of the prospectus).

The fund maintains a higher overall sustainability score than the MSCI Nordic Micro Cap (Net TR) index based on the investment manager's rating criteria. More details on the investment process used to achieve this can be found in the fund characteristics section of the prospectus.

The fund does not directly invest in certain activities, industries or groups of issuers above the limits listed under "Sustainability Information" on the fund's webpage, accessed via www.schroders.com/en/lu/private-investor/ gfc.

The fund may use derivatives with the aim of reducing risk or managing the fund more efficiently.

Benchmark: The fund's performance should be assessed against its target benchmark being to exceed the MSCI Nordic Micro Cap (Net TR) Index and compared against the Morningstar Nordic Small/Mid-Cap Equity Category. The fund's investment universe is not expected to overlap materially with the components of the target benchmark. The comparator benchmark is only included for performance comparison purposes and does not determine how the investment manager invests the fund's assets. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the target benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. **Dealing Frequency:** You may redeem your investment upon demand. This fund deals daily.


Distribution policy: This share class pays a semi-annual distribution at a variable rate based on gross investment income.

### Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. # What are the risks and what could I get in return?

# What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?
