WHAT IS THIS PRODUCT?

Type:

Investment fund (UCITS) under Luxembourg law, which is subject to the law for undertakings for collective investment of December 17, 2010 and which is a fonds commun de placement under this law. The fund's performance depends on the performance of the underlying investments.

Term:

The term of this product is indefinite and it has no maturity date. The manufacturer may reposition the product at any time, merge it with another product or terminate it unilaterally and without notice.

Objectives:

The investment objective is to preserve the capital on a long-term basis and to generate an adequate return through a mixture of investments which are compatible with the Sustainable approach. A hedging strategy by means of derivatives is used in order to avoid significant price declines.

The fund invests directly or indirectly in fixed or variable-rate securities from around the world as well as other permitted investments. The proportion held in shares and equities is limited to a maximum of 50%. Up to 100% of the investments can be made indirectly (via target funds). The target funds are selected in accordance with the requirements set out in the prospectus. At least 2/3 of the investments are selected by systematically taking into account ESG criteria in accordance with sustainability requirements, which contributes positively to fulfilling the UN SDGs. The fund is classified under Article 9 of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector («SFDR»). The securities are selected on a discretionary basis using a consistent investment process (active management). With regard to portfolio composition, the selection

of stocks and the associated weightings are focused on companies from the tailored benchmark index. The portfolio composition may deviate considerably from this benchmark index. The composition is set out in the sales prospectus. The investment policy is to outperform the benchmark index. The Asset Manager may at any time deviate – significantly or insignificantly, positively or negatively – from the benchmark index by actively overweighting or underweighting individual securities and sectors based on market conditions and risk assessments.

Fund units are issued and redeemed basically on every bank business day in Luxembourg.

Earnings and profits of the unit class are not distributed, but reinvested.

CACEIS Investor Services Bank S.A.14, Porte de France, L-4360 Esch-sur-Alzette, was appointed as the custodian bank (depository).

The liability of the assets of a fund within the umbrella fund for claims against the assets of another fund is excluded.

The investor has the right to convert his investment in the units of one sub-fund into the units of another sub-fund. Further information on unit conversion procedures can be found in the sales prospectus and the management regulations.

The risk indicator assumes you keep the product for 5 years.

We have classified this product as class 3 out of 7, which is a medium-low risk class.

Reasons for this risk classification: Equity market and company-specific price volatility; Interest-rate premium; Yield curve; Foreign currency risks.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This type of risk is not considered in the indicator shown above.

WHAT HAPPENS IF SWISSCANTO ASSET MANAGEMENT INTERNATIONAL S.A., LUXEMBOURG, IS UNABLE TO PAY OUT?

The assets of the Fund and the assets of the management company are held separately at the custodian bank. Therefore, a default by the management company will not affect the value of your investments in the Fund. If the custodian bank goes bankrupt, the Fund's assets deposited with the custodian bank will not be included in the bankruptcy estate but will be segregated for the benefit of the Fund.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- CHF 10 000 is invested.
- In the first year you would get back the amount that you invested (0 % annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario.

In principle, fund units may be redeemed on every bank business day in Luxembourg. Any costs are shown under «Composition of costs» above.
