What is this product?

UBS (Lux) Emerging Economies Fund is an undertaking for collective investment in transferable securities (UCITS) with the legal status of a Fonds Commun de Placement (FCP) established under Part II of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

Objectives

The actively managed fund invests primarily in emerging market government bonds denominated in hard currencies. The fund also allows opportunistic exposure to emerging market corporate bonds and local currencies.

The fund's country, interest rate and currency exposure is actively managed under strict risk control with the aim of profiting from market movements.

The sub-fund uses the benchmark JPM EMBI Global Diversified (USD) as a reference for portfolio construction, performance comparison and risk management. Although a portion of the portfolio may be invested in the same instruments and at the same weightings as the benchmark, the Portfolio Manager is not bound by the benchmark when selecting instruments. In particular, the Portfolio Manager may, at its discretion, invest in bonds of issuers not included in the benchmark and/or structure the proportion of investments in sectors differently from their weighting in the benchmark in order to take advantage of investment opportunities. In times of high market volatility, the sub-fund's performance may therefore deviate significantly from the benchmark.

What are the costs?
