#### What is this product?

The Fund was incorporated as a société anonyme, an open-ended fund formed under the amended law of 17 December 2010 on undertakings for collective investment. It is an umbrella fund with multiple compartments, the Sub-Fund being one of these compartments. The Shares are a

This actively managed Sub-Fund aims to generate long-term capital growth. It promotes environmental and social characteristics within the meaning of Article 8 SFDR by employing several safeguards and evaluates all equity investments against sustainability criteria with hard thresholds required to be met for inclusion. It mainly invests in equities and equity-like securities (including transferable securities that are qualified as closed-ended real estate investment trusts, participation certificates). It may invest up to 35% via Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect in China A-Shares.

The Sub-Fund mainly invests in securities issued by companies that are based and/or conduct the majority of their business activity in an emerging market and that include environmental or social characteristics in their economic activities. Emerging markets are, among others, countries included in the MSCI Emerging Markets Index. Type of approach: The investment manager excludes from the investment universe of the Sub-Fund, all companies producing controversial weapons, tobacco, and palm oil and companies who derive more than a de-minimus percentage of revenues from the following activities: nuclear energy, coal power or coal extraction, oil sands, weapons related military contracting, or adult entertainment, as well as tobacco retailers but with a higher revenue share, and also excludes companies that are evaluated to have failed international norms and standards. Based on systematic filtering of the remaining eligible investment universe, the investment manager seeks to identify market-leading companies by analyzing fundamental data of the companies, such as return on invested evaluated to have failed international norms and standards. Companies that provide the best outcome after the completion of the above described stock selection process (Leaders) represent the investment pool for the sub-fund. The outcome of such modeling is a sub-pool of Leaders that are considered potentially eligible for investment, the so-called Investible EM Universe. Sustainability (environmental, social and governance (ESG)) assessments are conducted on the Investible EM Universe. Measurable objective/Investment universe: The implementation of the sustainability selection criteria leads to the exclusion of at least 20% of potential investments via the exclusions applied to the starting universe (Emerging Markets equity markets) plus the further sustainability screening of the Investible EM Universe. Threshold: The ESG analysis covers at least 90% of the Sub-Fund's securities. Main methodological limits: potential inconsistency, inaccuracy or lack of availability of ESG data issued by third party providers. Up to 33% of the Sub-Fund's assets may be invested outside the aforementioned investment universe in other securities, other instruments, other asset classes, countries, regions, money market instruments and bank deposits to achieve the in-vestment objective and/or for liquidity management. It may also hold up to 20% of its net assets in bank deposits at sight.

#### Term

The Shares do not have a maturity date. The Product Manufacturer can terminate the Shares unilaterally. The Shares, the Sub-Fund and the Fund can be terminated early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

# What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

#### What happens if Vontobel Asset Management S.A. is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

### How long should I hold it and can I take money out early?

Recommended holding period: 6 years

Based on the investment policy and the risk profile of the Sub-Fund, a holding period of 6 years is recommended. Investors can sell the investment at any time, irrespective of the recommended holding period, without additional cost. Shares can be sold daily (on business days). Exit costs are presented above.
