## What is this product?

Type:
The Fund is a sub-fund of Waverton Investment Funds plc, an openended investment company with variable capital organised under the laws of Ireland as a public limited company pursuant to the Companies Act and authorised by the Central Bank of Ireland as a UCITS pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011.

## Objectives:

The Fund aims to achieve long-term growth on your investment.
The Fund may invest up to $100 \%$ of its assets, directly or indirectly through investment in other funds, in shares of companies worldwide and bonds, and in alternative asset classes (such as hedge funds, real estate, private equity funds and commodities) through investment in other funds.
The Fund may invest up to $40 \%$ of its assets in structured products. These are securities in which the issuer undertakes to provide a return to investors based on the performance of a reference asset such as an equity, bond, derivative, index or fund.
The Fund may invest no more than $20 \%$ of its assets in emerging market countries. The Fund may invest in shares issued by companies worldwide, including ordinary shares and preferred shares. A preferred share typically pays dividends at a specified rate and has preference over ordinary shares in dividends and the liquidation of assets.
The Fund may also invest up to $20 \%$ of its assets in bonds convertible into shares. ## What happens if Bridge Fund Management Limited is unable to pay out?
