What is this product?

The Product is a share of the Sub-fund Wellington Multi-Asset High Income Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) III SICAV (the "Umbrella Fund"), an open-ended investment fund with variable capital (société d'investissement à capital variable) of the umbrella type and is authorised under Part I of the 2010 Law and qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks to deliver a regular income with a secondary focus on capital growth by primarily investing either directly or indirectly in global assets including equities, sovereign, corporate and inflation linked bonds. The investment approach utilises a dynamic asset allocation across these underlying assets and may invest up to 70% in equity securities and up to 70% in fixed income securities.

The Fund will be actively managed utilising a dynamic asset allocation to support its aim to declare dividend income between 5%-8%, of its Net Asset Value in USD terms, per year. The Fund will generally be diversified across currency, industry, sector, issuer, market capitalisation and countries globally, including emerging markets. The Fund is managed based on the belief that generating consistent income in a multi-asset approach requires two key skills: sourcing unique insights from all asset classes and then combining them effectively in a well-diversified portfolio. The Fund may invest, either directly or via derivatives, in shares and other securities with equity characteristics; bonds (fixed or floating rate) issued by government, agency, supranational or corporate issuers, mortgage and other asset-backed securities, securities that combine the features of corporate bonds and preferred stock, cash and cash equivalents, equity linked notes, and commodities (via derivatives). There are no limitations on the credit quality of individual securities. Currency is actively managed.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security, to create leverage and/or a short position, efficient asset allocation). Derivatives will form a significant part of the strategy and will impact performance.

The Fund does not consider a benchmark during portfolio construction or for performance comparison purposes.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation, alongside regular income, and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio. Investors in the Fund should be aware that, as set out in the Fund's Distribution Policy, dividends may be declared out of the capital of the Fund.

Recommended holding period: 5 years

Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
