

Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the FTSE 100 index (index) which is designed to reflect the performance of the shares of the largest 100 UK companies listed on the London Stock Exchange. DESCRIPTION OF INDEX: The companies are selected on the basis that they have the largest combined value of shares as compared to other companies on the London Stock INDEX REBALANCING, CALCULATION ADMINISTRATION: The composition of the index is reviewed quarterly. The index is a price return index. This means that the level of the index does not include any dividends and distributions made by the companies. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying all or a substantial number of the securities in the index. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These

techniques and instruments may include the use of financial contracts (derivatives). The fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the fund. You may request the redemption of shares generally on a daily basis.

Risk and reward profile


Secondary market investors (those who buy or sell shares on a stock exchange) may be charged certain fees by their stock broker. These charges, if any, can be obtained from such stock broker. To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 82% of the associated revenue, the securities lending agent, which will be a Deutsche Bank entity, will be allocated 9% and the remaining 9% will be allocated to the DWS entity which monitors such activities, as set out in the sales prospectus and/or supplement, for its own coordination and oversight tasks. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.
